### Presentation purpose:

The 2026 Matthew Bulfin Educational Conference includes presentations for healthcare professionals on topics including embryonic biotechnology, bioethics in end-of-life care, reversal of mifepristone with progesterone, maternal mortality, abortion and mental health, restorative reproductive medicine, and more.

### Learning objectives:

- Diagnose and manage complex obstetrical and psychological issues in reproductive health.
- Evaluate the data supporting efficacy and safety of progesterone in antagonization of mifepristone.
- Using evidence-based cycle charting methods, diagnose and manage underlying health issues that contribute to infertility and other reproductive health challenges for women.
- Strategize with peers on how to contribute to the body of scientific and medical information while upholding Hippocratic principles.
- Discuss the impact of public policy on medical practice, including conscience rights for healthcare professionals and public policy's impact on maternal mortality and induced abortion rates.
- Articulate ethical considerations for medical interventions at the beginning and end of life, including ending a preivable pregnancy for maternal-fetal vital conflict and euthanasia/assisted suicide.
